**A TAX DISCOUNT OF 1% IS AVAILABLE ON  
TAX PAYMENTS UP TO JUNE 30, 2013.**

**TAXES ARE DUE AND PAYABLE BY SEPTEMBER 30, 2013**

All taxes remaining unpaid after September 30<sup>th</sup>, will have a penalty added onto them on the first day of each month thereafter at a rate of 1% per month until all the taxes are paid.

**ARREARS SHOWN ARE AS OF MAY 8, 2013 AND PENALTIES  
WILL BE CALCULATED WHEN PAYMENT IS BEING MADE.**
