## **BY-LAW NO. 04/06**

## BEING A BY-LAW OF THE TOWN OF MORRIS FOR REGULATING THE OPERATION OF LICENSED OFF-ROAD VEHICLES WITHIN THE LIMITS OF THE TOWN OF MORRIS.

**WHEREAS** the Council of the Town of Morris deems it necessary and in the best interest of the Town of Morris to control the use of licensed off-road vehicles within the limits of the Town of Morris;

**NOW THEREFORE** the Council of the Town of Morris, in session duly assembled, enacts as follows:

- 1. **THAT** By-law 12/95 be hereby repealed.
- 2. **THAT** licensed off-road vehicles are prohibited from traveling on any road in the Town of Morris except as follows:
  - a) Designated routes as shown on attached Schedule "A";
- 3. **THAT** within the limits of the Town of Morris, operators of licensed off-road vehicles are permitted to operate their vehicles for purposes of taking the most direct route into or out of the Town of Morris to or from their residences;
- 4. **THAT** licensed off-road vehicle operators who do not reside within the limits of the Town of Morris shall be permitted to enter the limits of the Town of Morris, provided that they take the most direct route to or from their place of destination, as provided for in Section 1;
- 5. **THAT** any person operating a licensed off-road vehicle within the limits of the Town of Morris shall be restricted to a speed limit of not more that 30 kilometers per hour;
- THAT the operation of licensed off-road vehicles on school and golf course property is prohibited;
- 7 **THAT** the operation of any licensed off-road vehicle within any residential area within the Town of Morris shall not be permitted between the hours of 12:00 midnight and 7:00 A.M.;
- 8 **THAT** any person operating a licensed off-road vehicle within any residential area within the limits of the Town of Morris must be sixteen years of age or over and must hold a valid Driver's License;
- 9 **THAT** all other regulations and restrictions in respect to the operation of licensed off-road vehicles shall be those as provided for under The Off-Road Vehicles Act of the Province of Manitoba, and
- THAT any person who violates any provision of this by-law is subject to a fine not exceeding \$50.00, or to a period of imprisonment of not more than 30 days, or both such fine and imprisonment unless otherwise provided for under any other Act of the Province of Manitoba.
