WHEREAS the applicant Samuel W. Teichroew proposes to split three urban residential lots to a total of six residential lots. All lots will gain access off Agassiz Trail via new driveways. Side-by-Side duplexes are proposed in each lot, where all will be serviced by municipal sewer and piped water

NOW THEREFORE BE IT RESOLVED that Council approve the above-mentioned subdivision with the following recommended conditions from Community Planning:

- Variation orders for the site width of the lots, to vary the minimum requirements of 60 feet to 30;
- That an engineered subdivision drainage plan is provided, and that any concerns with the drainage and flooding are satisfactorily addresses; and
- That the applicant enter into a development agreement with the Town of Morris to address any potential concerns respecting any items identified in Section 135 (3) of the Planning Act.
- And that lots only be used for the construction of duplexes as per the proposed subdivision.
