- c. For the taxable years of 2023 to 2027 inclusive, a tax incentive grant of the Municipal portion of taxes only in each year, equal to the following:

2023-100% (of the municipal portion of taxes only)

2024-80% (of the municipal portion of taxes only)

2025-60% (of the municipal portion of taxes only)

2026-40% (of the municipal portion of taxes only)

2027-20% (of the municipal portion of taxes only)

d. Should the building be sold, damaged, destroyed or cease operation; all obligations of the Town of Morris shall cease for such periods of time.
