Morris Area Foundation – There have been two significant events to report on since the last CAAW meeting.

The first is the Endow Challenge which ran for the week of November 13 - 19. MAF used social media, a direct mailing, posters, and a booth at Morris Bigway to promote the event. The final number raised with the matched dollars was \$42,503.73 which is up from last year's event. This is a good indicator that the MAF is becoming recognized as an important foundation for our community and the surrounding area. MAF's fund totals are \$551,137.61 as of end of November.

The second event was the MAF's Granting Awards Celebration on December 5, 2023. The Foundation issued grants in the amount of \$19,000 with a commitment for another \$7,500 from next year's grants. The following were recipients of this year's grants.

- Morris Community Gardens for raised garden beds.
- Valley Agri. Society to widen the grandstand steps and add handrails.
- Sperling Community Centre to add fire protection and security lights.
- Morris School Band Program for upright bass pick up and other equipment purchases.
- Morris Wellness Centre for the addition of a hip thrust machine.
- Rosenort Community Centre for tree planting in area parks.
- Morris School for senior year's kitchen upgrade.
- Morris Multiplex to add an automatic door opener for access to the arena.
- Morris District Centennial Museum to create an Honour Bench and Arbour.
- Willow Park Committee for phase 2: a picnic shelter and washrooms.

Community Partners – met on November 23, 2023 with a combination of in person and web based.

Matt Norris chaired the meeting. Minutes from last two meetings/updates were shared and approved. (submitted to the office for filing)

Each of the facilities in the area updated the meeting on how it was going. Doctor and nurse shortages continues to be an issue. The Facilities are covering the needs with the existing staff and Locum's when necessary.

- Morris Hospital has a high priority with Southern Health for a new doctor. Matt indicated that the nursing staff is in pretty good shape.
- Emerson Health Centre Dale indicated that they are about 60% staffed. They have added two Health Care Aide positions, one which has been filled. They are still needing more nursing staff, One full time position and two part time positions.
- Red River Valley Lodge Reported nursing staff is okay but Health Care Aides are short. This is being covered by Locum's.
- Vita Reported they have seven beds open but are short on nurses.

Comments were made on the importance of assisting with keeping people in their own homes and not having to rely on personal care.

Maintenance – Many examples in all facilities for general maintenance. Morris General Hospital has been approved for the upgrades to the nurse's desk. This is partially covered with funds from the Health Fund held by MAF.

Red River Valley Lodge - upgraded their microwashers, this was also supported by the MAF. Next on RRVL list for

Elderly Care – increased need for home care, assisted living suites to help our elderly. Leslie also reported that there is a 40% increase in use of the food bank.

Economic Development – Committee has met twice to further review the website developments. Website is close To ready and discussions took place on our launch plans. Looking to do something early in the new year.

Met with Cushman-Wakefield about the Industrial Park for ideas on increasing the presence. Options suggested:

- Enlisting services of a digital advertiser
- Increased signage it was agreed that highway signage would be an asset.

We also heard from a developer that may interested in developing the Industrial Park, meeting has been arranged with them.

Members of Council joined a virtual meeting with Ryan Coulter from MB Infrastructure and Transportation, to provide us with an update on highways in our area. We expressed concerns about highway 75 north and south as well as highway 23 west. All are priority areas and he indicated he would like to see them in next year's budget. It was indicated that 75 north will be finished first thing next year including final coat on the portions that were opened for winter travel. Properties south of town that are now inside the new dike will remain with the Province of Manitoba.

- Youth Volunteer of the year awarded to Owen Lewis, Volunteer of the year was awarded to Tim Lewis and the Red hat Membership was given to Marcel Sarrassin.
- Announced at the AGM that in 2024 The Manitoba Stampede and Exhibition will see the return of the RCMP Musical Ride!

Morris District Chamber of Commerce – Held "Ring of Influence" event on December 1st, 2023. Attendance was good, feedback was good in regards to speakers Mayor Scott Crick and Manitoba Chambers of Commerce President Chuck Davidson.

Community Futures Triple R Report – Jason Denbow, executive director for CF Manitoba is now back on the CF National Board. He met with Minister Vandal who informed him that there would be no new money for anything this year unless it had to do with housing.

There will be a strategic planning session on January 11^{th} which will include CF Manitoba Board members and managers, this will be led by Troy Dungate.

Morris District Handi Van Report – At the last meeting the committee reviewed its policy on wheelchair passengers-whereby safety purposes the policy states that all wheelchair passengers must have an escort.
